 - National Statistics Center, Ministry of Planning and Investment



Role of the National Focal Point

- (What was the role played by the national focal point in the process)
 - To oversee and discuss on its responsibilities regarding the roles of its sectors distinctively and unified for implementing civil management matters;
 - To steer on the policy regarding to civil management matters;
 - To steer and coordinate with ministries and other relevant organizations in order to proceed the implementation of civil management matters effectively;
 - To commend on the difficult and confused issues on civil management matters for unification;
 - To call for quarterly meeting among Coordination Committee in order to report t he potential status in the implementation of civil management matters according to the sectors' roles and planning for solutions in the future;
 - To report and ask for directions from the government for the special issues on civil management matters;
 - Others responsibilities regarding to upper level assigned.



Mandate of the coordination in the picture mechanism

(What is the mandate of the coordination mechanism? What is the work programme and how often do members meet?)

Development of CRVS strategy;

Review legislation related to CRVS;

- Develop CRVS database;
- Disseminate and raise awareness of the importance of the CRVS;
- Capacity building at national and local level;
- Quarterly meeting for CMCC.



Challenges

- (What were the main challenges with setting up the coordination *mechanism?*)
 - Difficulties in coordination and collaboration with relevant ministries concerns in CRVS matters.
 - There is no database for registration of births, death, and other civil registration in Lao PDR;
 - Lack of comprehensive legislations for CRVS;
 - MOHA has just been established, the capacity and experience of staff responsible for CRVS is limited;
 - Dissemination of CRVS has not reached rural and remote areas;
 - Provision of budget, vehicles, and equipment for CRVS does not fulfill the need.
