

Project Title: Youth Consultations and Regional Virtual Forum in preparation for the Second Ministerial Conference on CRVS in Asia and the Pacific

I. BACKGROUND

In November 2020, UN ESCAP and CRC Asia entered into a partnership agreement to harness political commitments and to advocate the voice and views of children and youth in identifying and overcoming challenges in meeting the Regional Action Framework for Civil Registration and Vital Statistics (CRVS) in Asia and the Pacific's goals and targets. This will be done through the conduct of a series of consultations and forums for children and youth.

The project is expected to result to a consolidated joint statement to be delivered through a recorded video during the *Second Ministerial Conference on Civil Registration and Vital Statistics in Asia and the Pacific* (2nd MCCRVS), and a full narrative report derived from the results consultations and forums.

In September 2021, the partnership agreement was amended to extend the partnership agreement to 15 November 2021 from the original 15 March 2021, expand the project activities, and increase the budget to USD 25,000 from the original USD 10,000.

The expanded activities include the conduct of a regional forum of civil society organizations (CSOs) to develop their recommendations to the 2nd MCCRVS, taking into consideration the results of the consultations with children and youth.

With this, the additional expected outcomes of the project include a list of identified CSOs interested in taking part of the efforts to improve the CRVS systems; a joint statement of CSOs for the 2nd MCCRVS; and a set of communication materials promoting child participation on CRVS issues and the recommendations from the children and youth consultation.

In fulfilling these objectives and achieving the results, UN ESCAP and CRC Asia also collaborated with World Vision International, as well as with UNICEF East Asia Pacific Regional Office and UNICEF Regional Office South Asia.

II. EXPECTED OUTCOMES OF THE PARTNERSHIP

a. Consolidated joint video statement of children and youth for the 2nd MCCRVS

Children and youth who took part in the series of consultations developed their video statement that was shared during the 2nd MCCRVS.

b. Full narrative report of the series of consultations and forum with children and youth

This report presents the views, experiences, and recommendations of 561 children and youth from 11 countries across Asia and the Pacific on CRVS, gathered through a series of discussions and consultations from March to April 2021.

A number of civil society organizations were contacted to take part in the Regional Forum of CSOs on CRVS: A preparatory Event to the 2nd MCCRVS in Asia and the Pacific.

The list includes 15 CSOs working at the international-level, 9 based in Afghanistan, 5 in Australia, 10 in Bangladesh, 8 in Cambodia, 27 in India, 9 in Indonesia, 9 in Laos, 8 in Malaysia, 21 in Myanmar, 26 in Nepal, 35 in Pakistan, 28 in the Philippines, 25 in Sri Lanka, 38 in Thailand, 6 in Vanuatu, and 9 in Vietnam.
