## **CHAPTER 1**

## **General Provisions**

# Article 1

"The National Steering Committee for Civil Registration, Vital Statistics and Identification", abbreviated as "NSCI" is formed to facilitate the implementation of the National Strategic Plan on Identification 2017-2026.

## **CHAPTER 2**

## Composition

### Article 2

NSCI has the following composition:

Permanent Member

- Minister of Interior Chairman - Secretary of State of the Ministry of Interior in charge of Vice Chairman identification - Secretary of State of the Office of the Council of Ministers Member - Secretary of State of the Ministry of Economy and Finance Member - Secretary of State of the Ministry of Planning Member - Secretary of State of the Ministry of Health Member - Secretary of State of the Ministry of Justice Member - Secretary of State of the Ministry of Foreign Affairs and Member **International Cooperation** Secretary of State of Ministry of Post and Telecommunications Member

Besides the above members, NSCI may request to include more members as the secretaries of state of relevant line ministries as necessary.

The actual composition of NSCI shall be appointed by the government's sub-decree.

- Director General of the General Department of Identification

Each member shall attend a meeting upon invitation from the Chairman of NSCI. If a member cannot attend the meeting, that member shall appoint an authorized representative to attend the meeting on their behalf.

NSCI may invite the secretaries of state of relevant line ministries to join the meetings, discussions or cooperation as necessary.

## **CHAPTER 3**

## **Roles and Duties of NSCI**

## **Article 3**

NSCI as an inter-ministerial mechanism at the national level helps the government to lead and coordinate the cooperation and support from relevant line ministries, national and international organizations, private sector, local mechanisms and any relevant countries to promote and implement the national identification reform, especially related to civil registration and vital statistics.

#### **Article 4**

NSCI has the following main duties:

- Encourage the implementation of national policies, laws, regulations and international conventions, covenants and treaties in which Cambodia is a signatory concerning civil registration, identification and vital statistics.
- Coordinate, lead and guide the implementation of the National Strategic Plan on Identification 2017 2026.
- Initiate the development of and the amendment to laws and regulations to provide appropriate environment for the development of the identification management system using telecommunications and information technology.
- Ensure consistency between the reform of the identification management system and the Decentralization and Deconcentration and other government's reforms to improve the effectiveness of identification service delivery at all levels.
- Create coordination forums between the government and the development partners to coordinate the cooperation and support for the implementation of the National Strategic Plan on Identification.
- Issue necessary guidelines and decisions on work related to civil registration, identification and vital statistics.
- Consult and coordinate with relevant line ministries whose work is related to identification to support the development of the integrated system for population identification.
- Based on the National Strategic Plan on Identification 2017-2026, action plans and annual budget shall be prepared.
- Examine the creation of new roles, improvement of some roles of institutions whose work is related to identification and decide on the development and use of Information and Communication Technology based solutions.
- Ensure the creation of valuable and reliable sources of information from all the people in the Kingdom of Cambodia, which then become accurate population data to serve public and private sectors.
- Monitor the progress and the actual implementation to ensure that all activities are carried out properly so as to prevent failure.
- Make reports on the implementation of the laws, regulations related to civil registration, identification and vital statistics and the progress and challenges in the implementation of the National Strategic Plan on Identification 2017-206 to the government once a year.
- Fulfill other duties assigned by the government.

#### **CHAPTER 4**

## **Functioning of NSCI**

NSCI shall have a meeting in every six months to review key indicators from the implementation of the National Strategic Plan on Identification and address challenges faced.

If necessary, **NSCI** may convene extraordinary meeting at the invitation of the Chair. Formality for **NSCI**'s meeting shall be provided in the internal rules of NSCI.

**NSCI** shall develop and adopt the working formalities and internal rules in its very first meeting.

## Article 6:

**NSCI** shall prepare annual summary activity report and propose recommendations to the Royal Government at the end of every year.

#### Article 7:

NSCI is entitled to invite representatives of relevant ministries/agencies, NGOs, international organizations and development partners to participate in its meeting to provide inputs or serve as observers as necessary.

## **Article 8:**

General Department of Identification will serve as the Secretariat of NSCI. The Secretariat will propose to establish "The National Technical Program Implementation Team or TPIT" to support the Secretariat in the implementation of the National Strategic Plan on Identification.

The organization and functioning of **TPIT** will be determined by **NSCI**.

### **Article 9:**

**NSCI** will use the seal of the Ministry of Interior.

#### Article 10:

**NSCI** may appoint and engage a number of national and international consultants as necessary to support **NSCI** and **TPIT**.

## **CHAPTER**

#### Sources of Resources

#### Article 11:

NSCI will develop action and budget plan to implement the National Strategic Plan on Identification, 2017-2026.

Resources of NSCI are provided in the budget package of the Ministry of Interior and may receive funding from international development partners.

### **CHAPTER 6**

## **Final Provision**

### Article 12:

Any provision contradicting this Royal Degree is nullified.

## Article 13:

Samdech Aka Moha Sena Padei Techo **Hun Sen**, Prime Minister of the Kingdom of Cambodia is tasked to implement this Royal Decree from the date of the signature.
